AMHA INTERNATIONAL JUDGE APPLICATION

Instructions: This application is to be used to apply for status as an International Judge.

All International applicants must first attend an AMHA Seminar, where they are required to attend AMHA Rulebook Testing, Interviews, and an AMHA Session. The License Official Committee will review your file at this time.

Return this completed application with the fifty-dollar (\$50.00) application fee, Associate Member fee of seventy-dollar(\$70.00), and a recent full-length photograph of yourself in judging attire to the American Miniature Horse Association at the above address.

If you are accepted as a AMHA International Judge, you may apprentice three (3) shows in the United States and apply for “Approved” Judge Status.

AMHA judge cards, valid for one year (1), will be issued to applicants upon approval by the AMHA Licensed Officials Committee (LOC). Judges cards must be renewed annually.
